- 3) Two contestants per boat only. On the morning of the tournament, each boat team will be assigned a boat number by order of entry fee payment and registration. Keep this boat number card in your possession. It will be used for take-off, check-in, and weigh-in identification. All boats must present their boat number, and leave from and return to the designated check in point.
- 4) No trolling allowed. Artificial bait only. No fishing within 50 yards of an anchored boat. **NO HORSEPOWER EXCEEDING BOAT LIMIT ALLOWED**
- 5) If late to weigh-in boater will be **DISQUALIFIED**.
- 6) Safe and courteous boating practices must be observed at all times. All contestants must wear PFD's any time the motor is in operation. Each boat must meet all US Coast Guard regulations. No alcohol or illegal drugs permitted.
- 7) Fish must be kept in live well. Any fish that appears to be in a questionable condition will not be weighed.
- 8) At least one team member must attend a meeting at <u>5:30 am</u> on the morning of the tournament.
